State and Local transfer tax are 1% except for Radnor is 1.5% and Upper Providence is 2.0 %

When a deed conveys property in more than one municipality, it is required to STATE what portion of the total value is credited to each taxing body with a Pennsylvania Statement of Value

LOCAL REGISTRY OF DEEDS:

Deeds in the City of Chester must be registered with the city through the Recorder of Deeds office ONLY (610-891-4148)

PLEASE NOTE THAT DOCUMENTS THAT ARE NOT CLEAR AND LEGIBLE WILL BE RETURNED AS UNRECORDABLE.

NOTARIES PLEASE NOTE – WE WILL NOT ACCEPT SEAL, SIGNATURE AND INK PRINT ON TOP OF EACH OTHER. PRINTED STAMP MUST BE CLEAR. WE WILL NOT TAKE IF FILLED IN.
